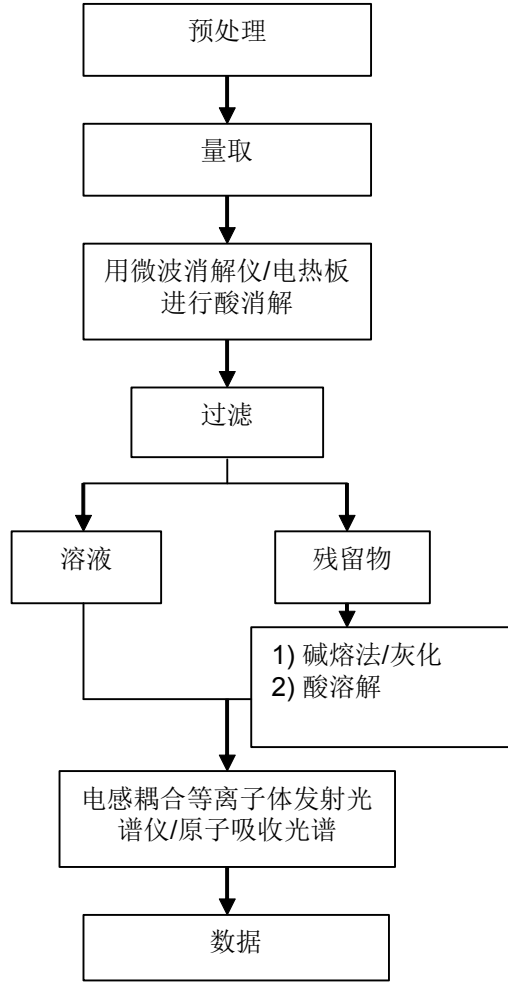

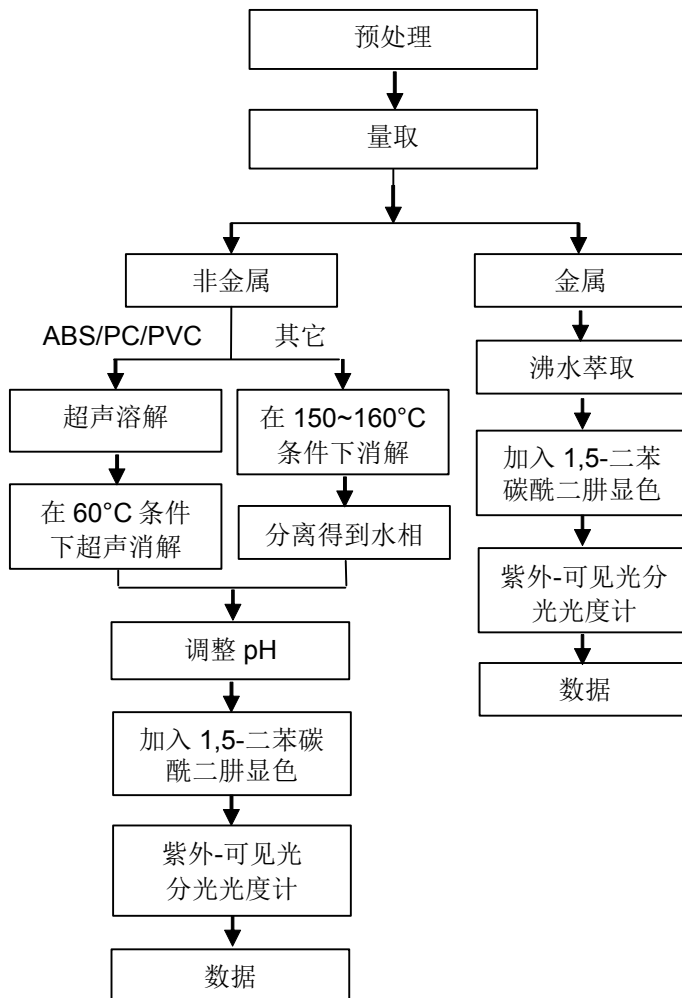

六价铬测试流程图



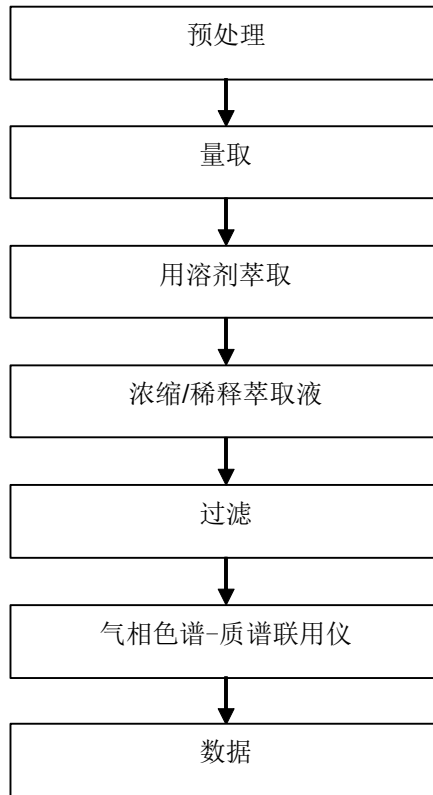

PBBs/PBDEs 测试流程图



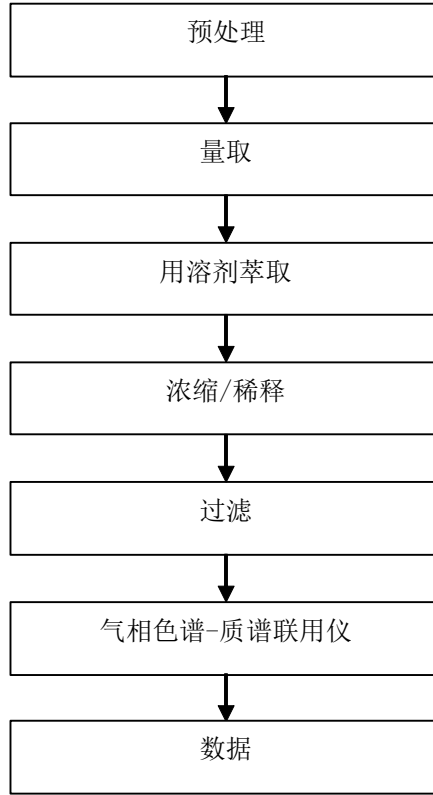

Phthalates 测试流程图

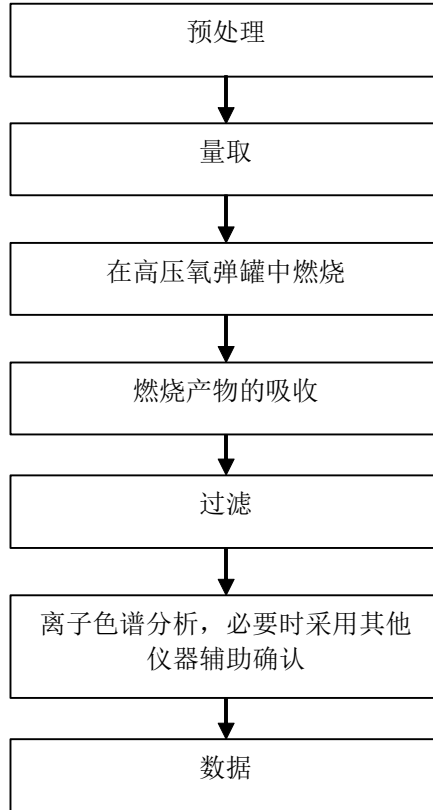

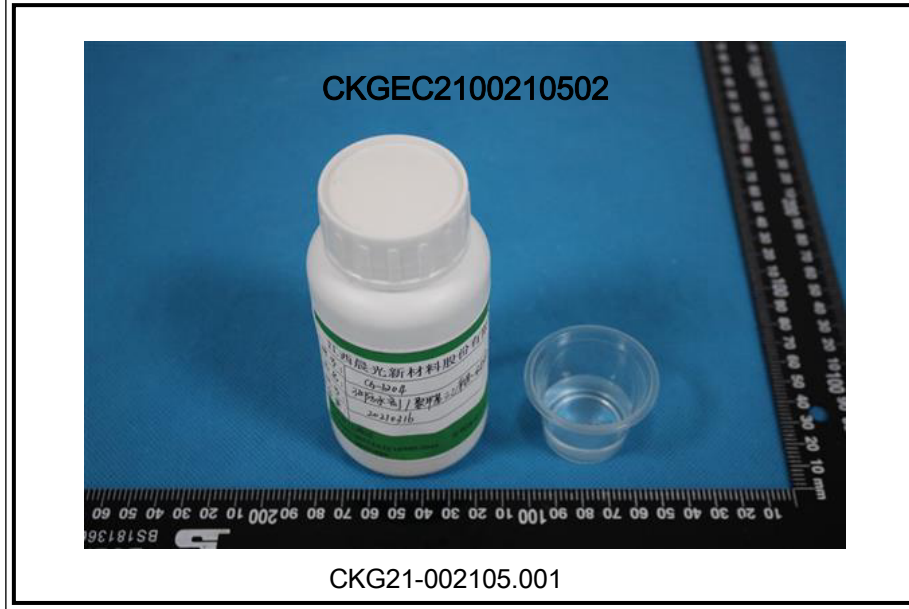
卤素 (氧弹法)测试流程图
